




### Changes in Operating Revenues by Segment Q4 2015 Compared to Q4 2014






#### Changes in Segment Income by Segment Q4 2015 Compared to Q4 2014






#### Changes in Operating Revenues by Segment Fiscal 2015 Compared to Fiscal 2014





#### Changes in Segment Income by Segment Fiscal 2015 Compared to Fiscal 2014






### **Quarterly Performance Trend**
