The Company's shareholders approved the Amendment on February 13, 2019. The Amendment increased the number of shares that could be granted under the plan.
- The strike price of the grant was set by the Company's Board of Directors at 113.5% of the closing price on December 4, 2018.
- The options vest in equal tranches on each of the third, fourth, fifth, sixth and seventh anniversaries of the grant date.
